Privacy policy

1. Personal data controller

Seco Industries, s.r.o. declares that, pursuant to Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation; hereinafter referred to as "GDPR"), this website complies with this regulation

2. Personal data processed

In connection with this website, we only process personal data that you provide to us via the contact forms on our website and information from cookie files/records or other information of a technical nature as specified in the network internet protocols.

This includes, in particular, the following data: name and surname, email, telephone number, any other data voluntarily provided by you in the contact forms and their attachments.

3. Reasons for the processing of personal data

The main reason for processing your personal data is to ensure the processing of your requests in the contact forms.

We also process your data for the purpose of carrying out analyses and measurements to determine how our website is visited and to improve the quality of our presentation.

4. Access to your personal data

We carefully select our partners to whom we entrust your data and who are able to ensure such technical and organisational security of your data that unauthorised or accidental access to your data or its misuse cannot occur.

All of our partners are bound by confidentiality obligations and may not use the information provided for any purpose other than that for which we have made it available to them.

The third parties that may have access to your personal data, depending on the nature of the service you use or have used, are:

persons to whom we provide data for the purpose of analysing traffic to our websites

persons who provide the technical operation of a particular service for us or operators of the technologies we use for our services

persons who ensure and test the security and integrity of our services and websites for us

Under certain conditions defined by law, we are then obliged to transfer some of your personal data to the designated state authorities (Police of the Czech Republic, etc.) or public administration authorities on the basis of valid legal regulations.

5. Legality of personal data processing

We may process your personal data on the basis of your consent, but also, for example, on the basis of our legitimate interest or for the performance of a contract between us, to the extent that the personal data is necessary for such performance. Last but not least, the reason for allowing us to process your personal data without your consent is to fulfil our obligations under the law.

We may process your personal data without your consent, but only for the purpose of

- a) fulfilling the obligations arising for us from generally binding legal regulations
- b) processing which is necessary for the purposes of our legitimate interests

The possibility and lawfulness of such processing arises directly from applicable law and your consent to such processing is not required.

6. Duration of processing of personal data

We will process your personal data on the basis of your consent for a period of 10 years, unless your consent to the processing of your personal data is withdrawn.

At the same time, we would like to point out that we must process those personal data that are necessary for the proper provision of the service or for the fulfilment of all our obligations, whether these obligations arise from the contract between us or from generally binding legal regulations, irrespective of the consent you have given us, for the period of time stipulated by or in accordance with the relevant legal regulations, even after any withdrawal of your consent.

7. Security of personal data

Any personal information you provide to us is secured by standard procedures and technologies.

We regularly check the system for weaknesses and apply security measures to prevent unauthorised access to your personal data and to ensure that it is sufficiently secure in light of the current state of technology.

8. Possibility to withdraw consent to the processing of personal data

Withdrawal of consent does not affect the processing of personal data that we process on a legal basis other than consent (i.e. in particular if the processing is necessary for the performance of a contract, legal obligation or for other reasons specified in applicable law).

9. Voluntary provision of personal data

You voluntarily provide us with your personal data on the basis of your consent. However, failure to provide them may result in us being unable to process your enquiries and requests.

10. Information on the rights of the data subject

You have in particular the following rights:

- a) the right to withdraw consent at any time
- b) the right to correct or supplement personal data
- c) the right to request restriction of data processing
- d) the right to object to or complain about processing in certain cases
- e) the right to request data portability
- f) the right to access your personal data
- g) the right to be informed of a personal data breach in certain cases
- h) the right to erasure of personal data (right to be forgotten) in certain cases
- i) any other rights provided for in the Data Protection Act and the General Data Protection Regulation 2016/679
